The closed executive session ended at 10:00pm.

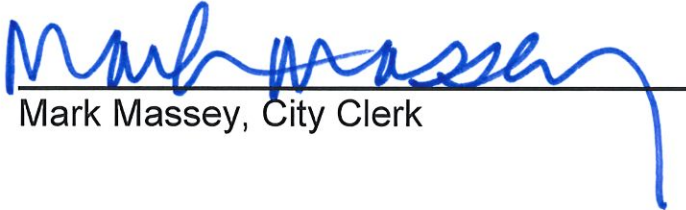
